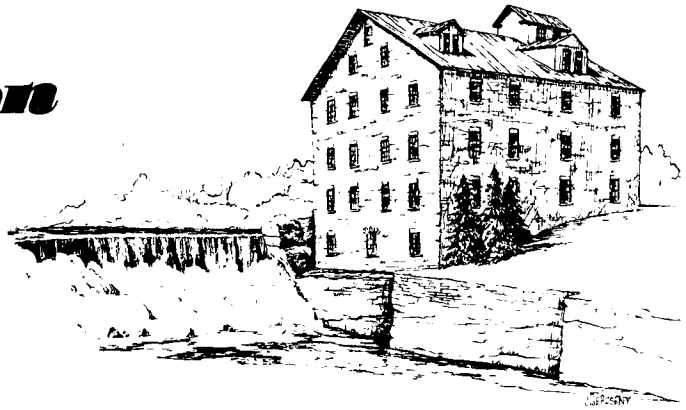

## 2008 TOWN BUDGET – ADOPTION

### *(Resolution 07-336)*

A motion was made by Mr. Vahue, seconded by Mr. Rooney, to adopt the following:

WHEREAS, at its regular Town Board meeting on November 26, 2007 this Town Board adopted the Preliminary Budget, as presented, and

WHEREAS, this Town Board has met at the time and place specified in the notice of public hearing on the Preliminary Budget and heard all persons desiring to be heard thereon, and

WHEREAS, pursuant to Part 617.5 (c) (20) of the implementing regulations pertaining to Article 8 (State Environmental Quality Review Act) the adoption of the Budget is a Type II Action, thus necessitating no further action.

NOW, THEREFORE, BE IT RESOLVED, that such Preliminary Budget as originally compiled, reviewed, and revised on this date and included in the minutes of this meeting, be adopted as the Annual Budget of the Town of Mendon for the fiscal year beginning the 1<sup>st</sup> day of January, 2008, and

BE IT FURTHER RESOLVED, that such budget, as so adopted, be entered in detail in the minutes of the proceedings of this Town Board, and

FINALLY, BE IT RESOLVED, that the Town Clerk shall prepare and certify, in duplicate, copies of said Annual Budget as adopted by this Town Board, together with the assessment rolls for benefit improvements, if any, adopted pursuant to § 202-a, Subdivision 2, of the Town Law and deliver one copy thereof to the Supervisor to be presented by him to the Monroe County Legislature.

### *(Resolution 07-337)*

A motion was made by Mr. Rooney, seconded by Mrs. Freeman, to table the previous motion.



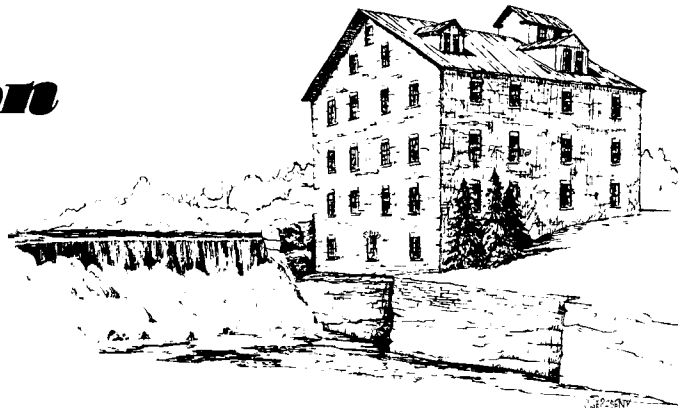


