TIM CZAPRANSKI – MONROE COUNTY EMERGENCY MEDICAL SERVICES OFFICE – **PRESENTATION**

Monroe County Emergency Medical Services Office Administrator Tim Czapranski appeared before the Board to deliver a general overview presentation of emergency medical services in Monroe County.

LOCAL LAW – SOLAR FARM ASSESSMENT OPT-OUT – CONSIDERATION FOR **ADOPTION**

The Board expressed their views concerning the adoption of this legislation. Mrs. Carroll stated that she was not against alternative energy, this legislation refers to taxing a business. She feels that the Board owes it to the residents to be fair. Mr. Roberts stated that the people he has spoken with does not feel that tax breaks to these businesses is fair. Mr. Hagreen stated that the Board has enacted legislation allowing solar farms, the bottom line is the people he has talked to are against tax exemptions. Mr. Dubois stated that the Town has gone farther than some by enacting legislation to allow solar farms and that if the small benefit the tax exemption allows is the only reason your business plan will be successful, then it is not a good business plan.

Section I. Legislative Authority.

This local law is enacted pursuant to the authority contained in Real Property Tax Law Section 487.

Section II. Opt Out of Real Property Section 487 tax exemption.

The Town of Mendon opts out of the tax exemptions provided by Section 487 of the Real Property Tax Law for Solar or Wind Energy Systems or Farm Waste Energy System constructed after the effective date of this ordinance.

Section III. Repealer.

All ordinances, local laws and parts thereof inconsistent with this local law are hereby repealed.

Section IV. Effective Date.

This law shall take effective immediately upon filing in the office of the Secretary of State, the New York State Department of Taxation and Finance and the New York State Energy Research and Development Authority.
