WHEREAS, in many communities throughout New York State, FIRST Robotics has grown beyond the traditional format of an extracurricular club, and has developed into a competitive sport that involves complex physical, mental, and social skills, and

WHEREAS, competition enhances the moral, physical, mental, and social development of the young people of this State, preparing them for the future by instilling in them the value of teamwork, encouraging a standard of healthy living, imparting a desire for success and developing a sense of fair play and competition, and

WHEREAS, it is the sense of this body that young people represent their community with pride and determination while participating in competitive events, they should be celebrated and recognized by all the citizens of the great State of New York.

NOW, THEREFORE, BE IT RESOLVED, that the Mendon Town Board encourages the New York State Board of Regents to make the First Robotics Competition a recognized varsity sport, and we call upon State Assemblyman Bill Nojay and State Senator Rich Funke, representing the people of Town of Mendon, to support this effort.

PROCUREMENT POLICY – REQUEST FOR INCREASE IN HIGHWAY SUPERINTENDENT'S EXPENDITURE LIMIT

Highway Superintendent Smith submitted a request to the Town Board to increase the amount of money he can spend without approval. Although recently raised from \$500.00 to \$1,500.00, he is requesting the limit be raised to \$2,500.00 due to the current cost of some repair items for large trucks. He submitted a stack of examples from 2014 where the Highway Department exceeded the \$1,500.00 level of expenditure. Supervisor Moffitt stated that the limit had been raised to \$1,500.00 in 2015. Mrs. Carroll stated that these expenditures did not follow that policy. Supervisor Moffitt stated that any expenditure amount approved did not include "emergency purchases" as the Highway Superintendent already had the power to make purchases related to public safety. Mr. Menz stated that during the winter, almost all truck related purchases may fall under the heading of "public safety." Supervisor Moffitt stated that a Town consultant who assists in the preparation of the Annual Financial Report, and who was a former state auditor, said the Town Board can put restrictions on what can be purchased without prior approval by the Board.

He wants to have the meeting at the Ambulance building.

AMBULANCE CONTRACT – LEGAL SPECIALIST

Supervisor Moffitt explained to the Board that he had taken two classes pertaining to emergency services at the Association of Towns training. Both were given by David B. Garwood, Esq., of the Pinsky Law

Group, PLLC. Because of the complexity of the agreement with the Village regarding ambulance service, including the fact that it is only allowed through special legislation of the state legislature, he feels that it is necessary to have a legal specialist representing the Town.
