HIGHWAY DEPARTMENT REQUEST - PURCHASE OF NEW DUMP TRUCK CHASSIS, BOX, PLOW, WING, AND SALTER AND DECLARATION OF SURPLUS, TRUCK #92 (Resolution 15-112)

A motion was made by Mr. Roberts, seconded by Mrs. Carroll, to a authorize the Highway Superintendent to purchase a new dump truck chassis, box, plow, wing and salter under Onondaga County, NY bid pricing, at a cost not to exceed \$203,389.00. PRESENTATION - PITTSFORD VOLUNTEER AMBULANCE, INC.

A major part of this investigation involves the possibility of merging the

Honeoye Falls-Mendon Volunteer Ambulance, Inc. with the Pittsford Volunteer Ambulance, Inc. The Village has appointed a Task Force involving Village personnel, representatives from both ambulance corporations, and the New York Council of Nonprofits, Inc. (NYCON) who became involved through a grant from the United Way of Greater Rochester. Doug Sauer, Chief Executive Officer of NYCON gave a Power-Point presentation entitled "Concept for Combining Honeove Falls, Mendon & Pittsford Ambulance Services" justifying the merger.

After the presentation the topic was discussed at length between the boards and members of the audience from different involved organizations, including the Mendon Fire Department, Mendon Fire District, Honeoye Falls Fire Department, Monroe County Office of Emergency Preparedness, among others.

Supervisor Moffitt explained that he would like the full Town Board to have this information before he suggested that. He did indicate that he was comfortable with the preparation of more financial information.
