LOCAL LAW 2015-01 - AMENDMENT TO ZONING CODE - LOT WIDTHS

Mr. Rooney recused himself from this discussion as he owns property that will be directly affected by this proposed local law. He left the Board Room at 7:14PM.

A motion was made by Mr. Moffitt, seconded by Mr. Roberts, to adopt the following and declare it a Type II Action under SEQRA:

A Local Law to amend Chapter 86, Definitions and Word Usage, and Chapter 200, Zoning, of the Mendon Town Code in relation to lot widths.

Be it enacted by the Town Board of the Town of Mendon, duly assembled:

I. Section 86-4 of the Town Code is amended as follows:

a. The paragraphs entitled LOT, FLAG and LOT, FLAG, ACCESS are deleted in their entirety.

b. The definition of LOT WIDTH is amended to read: The horizontal distance across the lot line between side lot lines as measured at the most narrow point.

c. The definition of YARD, FRONT is amended by deleting the following: The front yard of a flag lot includes only the interior or buildable portion of the lot and does not include the portion of the lot which provides access to a public street. (See "lot, flag.")

II. Section 200-8 of the Town Code, subdivision D, third sentence, is amended to read: Access is to be owned by fee simple title and be a minimum of 50 contiguous feet wide per lot.

III. Section 200-74 of the Town Code is amended to provide that the minimum lot width at ROW for RA-5 shall be 100, and RA-2 and RA-1 districts shall be 50 feet.

IV. This Local Law shall take effect immediately upon filing with the Secretary of State.
