AMBULANCE CONTRACT – VILLAGE OF HONEOYE FALLS

Supervisor Moffitt presented the Board with the latest version of the contract for ambulance services from the Village of Honeoye Falls. The Village Trustees have not approved it yet, so he wanted the Board to review it and get any comments to him by December 16th so they could be sent to the Village before they did. Mr. Hagreen asked about the final figure of \$89,997. Supervisor Moffitt answered that this was the fourth or fifth number the Town has received, starting last spring in the \$280,000 range from the former Village Administrator. This latest version addresses a number of financial concerns the Supervisor has brought to the Mayor's attention. Mr. Hagreen asked if the change in dollar amount would affect the service provided. Supervisor Moffitt stated that it would not. The Town is not legally required to have a contract with the Village for this service because the Honeoye Falls Mendon Volunteer Ambulance possesses a Certificate of Need from the State of New York that requires them to provide service in the entire Town of Mendon, contract or not. The Town has historically worked together with the Village on funding the department. Mr. Dubois asked about the population figures being used. Supervisor Moffitt stated that he had suggested the 2010 federal census figures because they were the latest verifiable figures he could find. Supervisor Moffitt commended the new Village Administrator Brian Anderson for his excellent work on this potential agreement.

AMBULANCE CONSULTANT - RENEWAL OF CONTRACT
